**Rebate details**

Xcel Energy issues rebates in the form of checks or utility bill credits. ACH payments are available to customers enrolled in Auto Pay through My Account. See the Qualifying Equipment section on this page for further details. ***This rebate only applies to existing single family homes with central air conditioning. Customers must also have a combination of residential electric and natural gas services or electric only service, in which electric heating is used.***

**Application details**

Account holder applications must be postmarked no later than September 30 of the year following installation of qualified equipment. Applications must include complete account holder and equipment information. No phone calls will be accepted to provide equipment verification. Xcel Energy reserves the right to refuse payment and participation if the account holder violates program rules and procedures. Xcel Energy is not liable for rebates promised to account holder as a result of a contractor misrepresenting the program.

A copy of a dated sales receipt or invoice must be included and contain the following information:

- Customer name and address
- Equipment manufacturer name
- Model number
- Product dimensions (height x width)

**All information on the receipt or invoice must match the information on the rebate application or the application will be returned.**

We reserve the right to conduct random inspections to verify installation of the rebated equipment at the address indicated on the front of this form. Your assistance is appreciated.

**Limitations**

Rebate qualifications and amounts are subject to change anytime. Our rebate programs may be cancelled with 30 days notice.

**Special promotions**

During special promotions for this program, it is the account holder's responsibility to ensure all paperwork is postmarked by the deadline. Xcel Energy will not pay special promotion incentive dollars in the event that a form is lost or not postmarked by the deadline, with no exceptions. Promotional rebate amounts will be automatically calculated by Xcel Energy. Promotion deadlines close at midnight on the date the application is due, with no exceptions.

**Rebate calculation example**

Customer purchases one 3 feet x 5 feet shade and one 5 feet x 8 feet shade.

Shade 1	3 feet x 5 feet = <b>15 square feet</b>
Shade 2	5 feet x 8 feet = <b>40 square feet</b>
Shade 1 + Shade 2	15 square feet + 40 square feet = <b>55 square feet</b>
Total square feet x \$1.33	55 square feet x \$1.33 per square foot = <b>\$73.15 total rebate</b>
